Elimination	Avoiding the risk altogether
Substitution	Reducing the risk by alternative means (use of less hazardous chemicals)
Engineering Controls	Using engineering measures (Powered access equipment, lifting equipment, guards, exhaust ventilation etc.)
Safe Systems Of Work	Designing suitable operational procedures, signs, signals, training and authorisation(s)
Personal Protection	Using personal protective equipment as a last resort for risk reduction
